Item: The 80th UNICA 2018 World Film Contest and Congress in the Town Blansko, Czechia - Application Form

Dear Mr Jan Essing,

The Czech UNICA Committee led by its president Mr Jan Vačlena Dipl. Ing. in time of its extraordinary meeting in November the 29th, 2014 in Kroměříž decided to ask the UNICA institution in charge of you for possibility of organizing of the UNICA 2018 event in the Czech Republic – in the town Blansko. This decision was followed by an approving resolution of the town Blansko administration given in April the 21st, 2015.

In 2018 the town Blansko will be celebrating its foundation with the first written mention about the town linked to the 100th anniversary of the Czechoslovak Republic creation in 1918, the 25 years of the Czech Republic existence and 80 years of the Czech organized amateur film movement establishment.

The town Blansko is also called „The gate to the Moravian Karst“ and „The gate to the Czech young filmmakers“ in the same time. The Czech UNICA Committee will and decision to organize the UNICA 2018 there is quite understandable of those reasons.

The town Blansko establishment is sure that UNICA 2018 event would bring a very important promotion for the town itself as well as for whole Blansko region via many foreign participants and member state representatives entering the UNICA 2018 contest and congress in Blansko.

There are well established all necessary conditions for contest and congress UNICA holding as well as for all event participants – film authors and guests from all over the world. The town Blansko is equipped by a digitalized cinema of 400 spectators capacity, a new Congress Hall of the Town Cultural Centre which also can contain 400 visitors. The Congress Hall is located just opposite the cinema. Boarding and lodging facilities in the town are reaching relatively high level with economic service prices at the same time.

Those facts have been confirmable during Mr Wolfgang Freiers visit there in 2014.

The latest UNICA event has been held in the Czechoslovak Republic in Hradec Králové in 1994. There is a term voted for eventual UNICA 2018 contest and congress in Blansko – the last week of August, 2018.

As a regular member of the UNICA organization we ask to discuss our proposal to organize the UNICA 2018 event in Blansko – Czechia in time of the UNICA 2015 congress agenda in St.Peterburg – Russia hoping in full success.
